<b>IF THIS HAPPENS</b>		<b>DO THIS</b>					
<b>Tanker/Vehicle Accident</b>		Switch off engine and electrical equipment. Keep people away and warn other traffic. Check for spills and leaks. Call the emergency services: Dial 111					
<b>Spill or Leak</b>		Wear overalls, chemical-resistant gloves and safety goggles. Prevent further spillage, and by any means prevent spillage from entering waterways. Contain spill and absorb with sand or other suitable material. Place spillage in a sealable container. Wash down affected area with large amounts of water. Dispose of spill container according to the regulations of the local authority.					
<b>Fire</b>		Call the Fire Department: Dial 111. Product is not flammable. No risk of violent reaction or explosion. Fire-fighters should wear full protective clothing suitable for chemical hazards with self contained breathing apparatus. Cool sealed drums with water spray to prevent rupturing. Contain and collect run-off (see Spill or Leak section above). Keep non-involved persons away. Any residues may be washed away with large quantities of water with the consent of the environmental authority.					
<b>FIRST AID</b>							
<b>If Swallowed:</b>		Rinse mouth. Do NOT induce vomiting Drink plenty of water or milk.					
<b>If in Eyes:</b>		Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing.					
<b>If on Skin:</b>		Remove/Take off immediately all contaminated clothing. Rinse skin with water/shower					
<b>If Inhaled:</b>		If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing.					
<b>STORAGE AND SEGREGATION SUMMARY</b>							
<b>Storage:</b> Keep out of reach of children. Store in plastic container as supplied/recommended by manufacturer. Check all containers are clearly labelled and free from leaks. Store locked up in cool dry place.
