IF THIS HAPPENS		DO THIS					
Tanker/Vehicle Accident		Switch off engine and electrical equipment. Keep people away and warn other traffic. Check for spills and leaks. Call the emergency services: Dial 111					
Spill or Leak		Wear overalls, chemical-resistant gloves and safety goggles. Dike spillage area to prevent runoff and contamination of water sources; Clean up by absorbing with sand or soil or diluting with water and then remove contaminants to a chemical disposal area. Dispose of spill container according to the regulations of the local authority.					
Fire		Call the Fire Department: Dial 111. Product is not flammable. Risk of violent reaction or explosion if mixed with chlorine. Fire-fighters should wear full protective clothing suitable for chemical hazards with self contained breathing apparatus. Cool sealed drums with water spray to prevent rupturing. Contain and collect run-off (see Spill or Leak section above). Keep non-involved persons away. Any residues may be washed away with large quantities of water with the consent of the environmental authority.					
FIRST AID							
If Swallowed:		Swallowed product can cause nausea, diarrhoea, burns to the mouth and digestive tract. Rinse mouth. Do NOT induce vomiting. Drink large quantities of water or milk. Call a POISON CENTRE (0800 764 766) or doctor/physician if you feel unwell. If medical advice is needed, have product container or label at hand.					
If in Eyes:		Contact with eyes causes serious eye damage. Flush immediately to reduce injury. Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do, continue rinsing. Call a Poison Centre or doctor/physician if irritation persists.					
If on Skin:		Causes severe skin burns. Wear protective clothing when handling product. Wash immediately area affected to reduce injury if contact with skin happens. Remove, take off immediately all contaminated clothing. Rinse skin with water/shower. Wash with plenty of soap and water. Wash contaminated clothing before re use.

Storage: Keep out of reach of children. Store in tightly closed original container in a cool, dry, well-ventilated area out of direct sunlight and away from sources of ignition when not in use.
